WHEREAS the licensee(s) having applied to the Excise Commissioner, Uttar Pradesh have obtained a licence for storage in Bond of Foreign Liquor/Beer/Wine/Low Alcoholic Beverages Bonded Warehouse at, the licence being entered in the records of Excise Commissioner as licence no dated

ANDWHEREAS the Excise Commissioner has required the licensee(s) to deposit security the sum of Rs..... by Bank Draft/ treasury challan in the favour of Excise Commissioner payable at Allahabad.

ANDWHEREAS the licensee(s) has/have deposited with Excise Commissioner, the securities as aforementioned.

ANDWHEREAS the condition of this Bond is that the licensee(s) shall observe all the provisions of Uttar Pradesh Foreign Liquor/Beer/Wine/Low Alcoholic Beverages Bonded Warehouse Rules, 2010 (hereinafter referred to as the said Rules) and in particular shall store Foreign Liquor/Beer/Wine/Low Alcoholic Beverages into the Bonded Warehouse and shall not remove or issue Foreign Liquor/Beer/Wine/Low Alcoholic Beverages from the licensed premises, before the consideration fee has been paid except as provided for in the said rules;

ANDWHEREAS if the licensee(s) pays/pay into the Government Treasury all the dues whether by the way of consideration fees payable by the licensee(s) under the provisions of U.P. Excise Act, 1910 (Act No IV of 1910), rules and orders made thereunder;

NOW, IT IS HEREBY, agreed and declared that the licensee(s) shall not transfer either by the sale or otherwise, the stocks of Foreign Liquor/Beer/Wine/Low Alcoholic Beverages to any person other than a licensed Wholesale vendor/ Bonded Warehouse and that the Government shall at its option be competent to recover the said amount in satisfaction of any claim for the loss of the excise revenue to recover, under U.P. Excise Act, 19010 the amount of such claim as arrear of land revenue and to otherwise its rights under the above written bond in any manner.
